- THAT the General Faculties Council Academic Policy Committee approve the draft updated Academic Schedule Dates & Deadlines 2020-21 as presented, effective September 1, 2020.
 Comments: It was clarified that this proposal is for the current academic year only. It was noted that GFC will be advised of the change to the academic schedule dates and deadlines.
- THAT the Academic Policy Committee approve the updated Academic Date Setting Procedure, on behalf of GFC, to be effective September 1, 2020 to support the development of the Academic Schedules for 2021-22 and onwards.
- THAT the Academic Policy Committee approve the Revised Academic Schedule and Dates & Deadlines 2020- 2021.
- To have the Academic Calendar approved now for the next academic year.

7. Fall Break Sub-Group

The Academic Policy Committee formed a sub-group of members of the APC to review a potential Fall Break for AUArts. The Sub-Group met three times in 2021 and conducted an open consultation session for faculty, students and staff on March 22, 2021. It then followed up with two surveys — one for faculty and one for students. The APC will review the data and submit a report and recommendation to GFC in Fall 2021. If the recommendation is approved, the academic schedule will be amended, and a Fall Break would be implemented as of Fall 2022.
