- c. create a substitute course that meets program requirements/degree progression requirements in order to respond to restrictions as a result of the government measures as a result of the pandemic, for the 2020/21 academic year only.

#### 5. Items Discussed

- GFC Agenda format: Several reports/minutes to appear later in the agenda.
- Student Association recommendation for outcomes to be made available for all courses.
- Election of GFC Vice Chair
- The Steering Committee provided an interpretation of the School Council Terms of Reference in two areas:
  - 1. In terms of eligibility, the terms of reference state that "all sessional who have taught for at least two academic years...". In order to facilitate participation, it was confirmed to not put roadblocks in the way of having a sessional faculty member participate in a school council.
  - 2. Are the academic years consecutive years or not? It was confirmed that file access for faculty members, who will be teaching in a specific semester, will be followed as per IT policies and access.
- The use of MS Teams Chat at GFC meetings was discussed.

#### 6. Unfinished Business

- GFC Standing Committee Annual Reports to GFC are to be prepared for the first meeting of each standing committee in September, then reviewed by SC and then GFC. The full report will be received by the Board of Governors, for information, and then the posted on the GFC website.
- GFC Standing Committee Chairs were asked to confirm the meeting format online or in person - for their committees for Fall 2021 and Winter 2022. The GFC meeting format will be confirmed at the September 1, 2021 meeting, when more will be known regarding public safety.
   When the GFC meeting format is confirmed, the discussion of MS Teams chat will continue.

# 7. Annual SC Feedback

Low response (38%). Strong engagement and knowledge of the mandate for committee members and it was felt the work of the Steering Committee is effective, and the Chair is effective.
